Department of

public works: Justin Parchert reported that he is aware that the dike needs to be

mowed. He's working on it. He said that there was a lot of work that needed to be done when he started and he's getting to each of the items. Justin asked the Board for permission to buy a self-propelled lawn mower, to cut down on the amount of weed eating that needs to be

done. The Board agreed to let him buy the equipment he needs to get his job done. The Board also agreed to let Justin buy a laptop to help with his

day to day business.

Justin informed the board that he has found a John Deere riding mower that he's interested in purchasing. He stated that the price of the mower will be \$13,250. The expense will come out of the Village Park

Fund. The Board gave him the go-ahead to purchase it.

Mayor: No Report

Old Business: Trustee Neece reported the need to revisit the Inoperable Vehicle

Ordinance. He has suggested a few changes that he believes would be great additions to the Ordinance. This will be addressed at the next Board

meeting on June 6, 2016.

New Business: Darren Parchert expressed his concern about the potholes in the road

leading to the yard waste dump site. The Board informed him that Trustee Woeber is getting a project list ready for the summer and that

road will most likely be on it.

The Board has expressed concern about certain lots within the Village limits being overgrown with weeds and grass. There is an Ordinance that addresses this. An article will be put into the newspaper and then shortly thereafter, violation letters will be sent out. The Ordinance states that it is a violation of the Weed/Grass Ordinance (NO. 607) for the growth to exceed eight (8) inches in height. The Ordinance also states that if after a period of ten (10) days after a warning letter, the Village will cut the grass/weeds at the owner's expense of \$80.00 per man-hour.
